1. **CALL TO ORDER; ROLL CALL**

a. Tree Plantings at Pebble Beach Apartments/Stoney Lakeside Park. The board discussed fall plantings along Bowes Road.

b. Tree for Jim Hall. A tree will be planted for Jim Hall along the Riverwalk.

7. **NEW BUSINESS.**

- a. **Tree Removal Discussion.** Rich LaBombard suggested trees be removed at 226 N. Center, 920 N. Hudson, 1236 Valley Vista and S. Monroe parking lot. By general consensus, the board agreed to remove the trees.
- b. **M21 Project – Placement of Two New Trees.** MDOT removed two trees near Main and Hudson. LaBombard suggested two new trees be purchased and planted near the 200 block of E. Main. The bill will be forwarded to MDOT for reimbursement.
- c. **Fall Plantings.** The board discussed possible fall plantings. The area behind Walgreens was considered.
